New Ohio Web Library Website

fter much testing and input from the library community, we offically launched the new and im-Lproved version of the Ohio Web Library on March 1, 2014. It has been completely redesigned with a new look, especially the "Sources" page, new features, and new search functionality (*http://www.ohioweblibrary.org*).

On the backend, we changed the way that search results are retrieved. Previously, we used an open source metadata software called Pazpar2 to index and retrieve search results. With the redesign, we have implemented a custom-built system for increased flexibility and customization. This new search makes use of the vendors' own search functions and algorithms because the vendors themselves are the most proficient at searching their own resources. The way that the search is performed is handled on a vendor-by-vendor basis, but we still rank the results on our end.



From the user perspective, the Ohio Web Library search functions basically the same, with the user entering a keyword(s) into the search box. order). Then, the user can select a specific resource and go directly to the database.

Both the search results and Sources pages look drastically different from the previous version of Ohio Web Library. Another new feature on the results page allows the user to select which sources to include or remove in a follow-up search (grayed out source means that no results were found.) If you want to view local database resources purchased by your library, either click on the "List of all sources" link and choose the "Locally purchased by your library" tab to enter a library card number, OR enter a library card number into the "Local Library Sources" box on the search results page. Voila!

One important note to mention is that we will no longer support versions of Internet Explorer below 10. The new Ohio Web Library will not properly work in outdated versions because they do not support HTML5 features. You will either need to upgrade IE or use a different browser, such as Firefox, Chrome, or Opera.

Amended Public Use Policy

uring our last Board meeting in February, we amended our Policy on Public Library Use of OPLIN. A library had recently inquired about offering Internet fax services to patrons rather than their current telephone-based fax services, but had concerns that their library would be violating the OPLIN policy against charging patrons for Internet services if they charged a cost recovery fee.

Since it had never been the intent of the OPLIN Board to force a library to offer Internet services at a deficit, we proposed that the Board alter the current policy. The proposed revision to the Policy on Public Library Use of OPLIN added the words, "other than cost recovery fees" to the clause.

Content Advisory Meeting

he OPLIN Content Advisory Committee Meeting took place at the OPLIN office on Wednesday, February 19. The Content Advisory Committee (CAC) is a past committee that had been inactive since 2008 and recently revived this year. Composed of 10 members, the CAC was created "for the purpose of working with the Board of Trustees of the Ohio Public Library Information Network to offer recommendations and provide information relevant to the electronic information resources purchased by OPLIN and shall limit its activities to advising on those matters only."

Basically, the primary role of the CAC is to discuss all issues related to the purchase of the statewide database resources, and the Board thought that these issues were better served by the CAC and left out of the OPLIN strategic plan.

During the meeting, the Committee discussed the current selection of resources in the Ohio Web Library collection, additional resources purchased by individual libraries to complement the collection, and types of resources that might be useful and available at low cost.
